

## 2020 State Junior Team Trials

The Junior State Team will be selected by the following events:

- Under 12 State Team Trial
- Under 15 State Team Trial
- Under 18 State Team Trial
- Under 18 Girls State Team Trial.

### Under 12 State Team Trial

- All juniors who are under the age of twelve (12) years as by the thirty first (31<sup>st</sup>) December prior to Australian Eight Ball Junior Championship
- The fee of this event will be stipulated by the WAEBF Board.
- No late payments of the fee will be accepted.

### Under 12 State Team Format

A round robin format, two (2) minimum of two (2) frames against all opponents trialling for that age group. The Winner and Runner up of the round robin will offered positions in the WAEBF Junior State Team.

Any players on a tied amount of points will play off in a race to three (3) to determine the player to receive that position.

The winner and runner up of this event will be given a State team acceptance letter, to be used for important information notice and government funding/grants.

### Under 15 State Team Trial

- All juniors who are under the age of fifteen (15) years as by the thirty first (31<sup>st</sup>) December prior to Australian Eight Ball Junior Championship
- The fee of this event will be stipulated by the WAEBF Board.
- No late payments of the fee will be accepted.

### Under 15 State Team Format

A round robin format, two (2) minimum of two (2) frames against all opponents trialling for that age group. The Winner and Runner Up of the round robin will offered positions in the WAEBF Junior State Team.

Any players on a tied amount of points will play off in a race to three (3) to determine the player to receive that position.

The Winner and Runner Up of this event will be given a State team acceptance letter, to be used for important information notice and government funding/grants.

### Under 18 State Team Trial

- All juniors who are under the age of eighteen (18) as by the thirty first (31<sup>st</sup>) December prior to Australian Eight Ball Junior Championship
- The fee of this event will be stipulated by the WAEBF Board.

- No late payments of the fee will be accepted.

#### Under 18 State Team Format

A round robin format, two (2) minimum of (2) frames against all opponents trialling for that age group. The Winner and Runner Up of the round robin will offered positions in the WAEBF Junior State Team.

Any players on a tied amount of points will play off in a race to three (3) to determine the player to receive that position.

The Winner, Runner Up and Third Place of this event will be given a State Team acceptance letter, to be used for important information notice and government funding/grants.

#### Under 18 Girls State Team Trial

- All juniors who are under the age of eighteen (18) as by the thirty first (31<sup>st</sup>) December prior to Australian Eight Ball Junior Championship
- The fee of this event will be stipulated by the WAEBF Board.
- No late payments of the fee will be accepted.

#### Under 18 Girls State Team Format

A round robin format, two (2) minimum of two (2) frames against all opponents trialling for that age group. The Winner and Runner Up of the round robin will offered positions in the WAEBF Junior State Team.

Any players on a tied amount of points will play off in a race to three (3) to determine the player to receive that position.

The Winner and Runner up of this event will be given a State Team acceptance letter, to be used for important information notice and government funding/grants.

#### Withdrawing from Junior State Team

The State Team acceptance letter will determine the closing date of when athletes are due to give their notice about withdrawing from the team as well as when levy payments are due.

If an athlete withdrawals at any time before the cut-off date then the position in the state team will be given to the next person in the standings from the State Team Trial. There will be no financial implications for the withdrawal.

If an athlete withdrawals between two to one (2-1) weeks outside the travel departure date then the vacant position of the state team will go to the next person in the standings from the state team trial, and allowance to pay the levy amount will be awarded to the athlete and parent. Payment to travel to the Junior Championships will be due no later than 1 month after returning from the Championships. If payment is late then the athlete and parent will be deemed un-financial.

The athlete that withdrew from the state team within the (two to one) 2-1 weeks may incur some financial implication.

### Travelling with Junior State Team

- At least one (1) parent or legal guardian must travel with the athlete to the Australian Eight Ball Junior Championships
- The parent/guardian will be eligible for the State Team levy
